**Recreation, Website & Chamber: Mrs. Wilt** reported the Chamber is doing their Bear and Wine Festival on October 5<sup>th</sup> and they have their logo worked out. They are also working on a tier list for Towns that want to participate based on how much they want to participate in the Chamber. **Airport: Mr. Wilt** reported that pre-applications were due for the lighting project, but the FAA isn't accepting the applications because of the government shut down. He said it doesn't look like the grants won't make it this year because we have to receive the grants in the March release in order to have time to get them completed. Any grants received during the October release wouldn't work as they have to be executed with in nine months.

Lake, Dam & Invasive: Mrs. Rudes reported there has been some back and forth with Paul Smith on the Popular Point location for the boat steward and boat wash station.
