WHEREAS: Marion Parslow started employment for the Town of Arietta on 7-11-2005 as a part-time employee with the intent at a later date to fill the vacant full-time position. She took the Hamilton County Civil Service exam for Account Clerk/Computer Aide on 10-13-2007. Then on 4-7-2008 was appointed into a provisional full-time position and full time permanent on 6-2-2008, and							
WHEREAS: the official policy of the Town, as set forth in the Town Employee Handbook in 2004 entitled eligible full-time employees of the Town who had 10 years of continuous service, are 55 or older, and retire into the NYS Retirement System with health coverage. On July 2, 2007 at the town board meeting resolution 07-07-27 was passed revising medical insurance for retirees to have 20 years of continuous service effective as of January 1, 2008, and							
WHEREAS: at the April 30, 2007 town board meeting it was noted that existing full-time employees would still fall into the 10-year category and new employees would fall into the 20-year category, and							
WHEREAS: in the past each application for benefits would be determined on an individual basis according to the facts presented to the Board and as Marion Parslow was hire in 2005 with the intent to fill the vacant fulltime position, which was prolonged, fell between changes made to the rules of health insurance benefits during her 16 years of employment as an account clerk/computer aide, (see the attached documents), and							
<b>THEREFORE, IT IS RESOLVED:</b> the Town Board, Town of Arietta after review of the facts as presented will authorize Marion Parslow medical insurance coverage at the time of her retirement into the NYS Retirement System.
