**Subject: FAA Grant Application for Federal Assistance for Piseco Airport
Snow Removal Equipment Building Upgrades – Design and Construction**

WHEREAS: the Town of Arietta has an agreement with the FAA and NYSDOT to continue with the scheduled projects outlined in the Airport Capital Improvement Plan for Piseco Airport

WHEREAS: the scheduled project for 2023 is the Snow Removal Equipment Building Upgrades for Design and Construction, and the town has received from our engineers, McFarland and Johnson, Inc. an application for Federal Aviation Administration grant funding, and

WHEREAS: the maximum cost of the 2023 project is estimated at \$110,000 which will be paid with 90% Federal funding (\$99,000), 5% State funding (\$5,500) and 5% Town funding (\$5,500), and

NOW, THEREFORE BE IT RESOLVED: that the Town Board, Town of Arietta hereby approves submitting the Grant Application for the above subject project; and it is hereby

FURTHER RESOLVED: that the Town Board, Town of Arietta does authorize the Town Supervisor to execute all necessary documents on behalf of the Town of Arietta with FAA and NYSDOT to apply and accept funding for Design and Construction Upgrades of Snow Removal Equipment Building at Piseco Airport.
