# **COMMITTEES:**

Snowmobile Trails- Jacqui had nothing new to report.

Craig reported that Brenden Whitkovits has passed his BTI course and is now a technician and he will be taking his course this week for chainsaw certification.

<u>Codes and Zoning</u>- Mel reported the building permits are beginning to come in. Brad Parslow is still working on his course.
